Mission Statement: Conduct a motorcycle ride from various locations to the Lake Waccamaw Boys and Girls Home to interact with the children while raising as much money for them without placing riders or children at risk.

Chapter Challenge: The Chapter Challenge concept allows you to gather your group, raise your funds, plan your route to the assembly area, set your timeline, and most importantly... present your check. We greatly appreciate the participation of other groups; however, we felt that we were stealing their thunder by submitting one check in our name. It's not about us... it's about the kids! With the Chapter Challenge, all groups submit their own check and whoever submits the largest check, takes the trophy home until next year. The school provides lunch, so it is included in the check you submit to the school. **We do need to get a ballpark headcount from your group by April 24, 2026, to ensure that we have everyone covered for lunch.**

Vass Leg: All who want to ride with Chapter 296 to the assembly area are welcome to meet with us in the parking lot at Burney Hardware Co, 11865 US-15, Aberdeen, NC 28315 at 0800 hours on May 2, 2026. We will have a cup of coffee, a pre-ride safety briefing at 0830 hours, and we will go KSU at 0900 hours. Route map is provided as enclosure 3. A trail vehicle with trailer will be provided. The return trip is at your discretion.

Cost: \$15.00 per single rider or \$25.00 with passenger. Cost includes lunch. If you would like to preorder a ride shirt, they may be ordered in advance before April 24, 2026, or by visiting www.ncpost296.com/shop. There will be door prizes and ride tee shirts available on the day of the ride for \$15, while supplies last. Please make checks payable to **ALR 296, PO Box 296, Vass, NC 28394-0296**.


Ride Route:
